When it came to my summer vacation I would think of a way to save money up Before my trip home I thought of a way with going back to invoices and changing cash customers into Free HAIRCUTS n taken the left over change n keeping it I did it to when draw was over during the day I would keep left over money my goal was to collect \$100 dollars a day for my vacation with that being said im working 6 days a week for month and with coupons and Free Haircut, ~~styles~~, ~~perms~~, and Shampoo with discounts on Haircuts & products it would be \$26,000. This \$26,000 dollar includes Free Haircuts discounts on Haircuts, Shampoo, long styles, regular styles, ~~shampoo~~ ^{shampoo} products, plus stole out from charge tips and Cash draw when I ~~present~~ ^{as} changed invoices.

I would hit buy one get one Free that way I can get Free products too

I did do this in other two salons I worked at most
